WELCOME: The President, Nigel Cleminson, advised that a quorum was established. He declared the meeting was fully constituted and opened the meeting at 10.30am. He welcomed all Club members and thanked them for their time in attending.

CONFIRMATION OF THE PREVIOUS MINUTES: The minutes of the 2025 AGM were taken as read. Nigel Cleminson moved that the minutes be accepted as a true and accurate record on the Annual General Meeting held on 16th March 2025. Seconded Jo Tavlian. Carried.

PRESIDENT'S REPORT: Nigel Cleminson presented his report on the club's activities and operation for the previous twelve months. Nigel Cleminson moved that the President's report be accepted. Seconded Avra Bowler. Carried.

TREASURER'S REPORT: Colin Gorton circulated the Treasurer's and Financial Reports to members present. Due to illness the Club's Auditor

has been unable to complete her report. A Special General Meeting will be scheduled to review and accept the report once it is completed.

The Treasurer read some additional notes to the Treasurer's Report.

1. Congress income continues to support the club by contributing \$4,600 to our surplus of \$7,233.

2. Despite inflationary pressures expenditure has been tightly managed by the committee with only a 4.5% increase on last year's figure.

3. The year's significant expenditure was the repair of the air-conditioning system at \$5000.

Statement of Remuneration and Benefits: According to the Incorporated Association Act, it was reported that Nigel Cleminson, serving as a non-playing director, received \$400 in remuneration. No member of the Management Committee has received any monetary or non-monetary compensation for their services. Colin Gorton moved that the reports be accepted. Seconded John Bullion. Carried

APPOINTMENT OF AUDITOR FOR 2027:

Nigel Cleminson moved that Julie Pettit of JPA Tax, be appointed as auditor for 2027. Seconded John Bullion. Carried.

INSURANCE CERTIFICATES OF CURRENCY:

All required insurances are in place and certificates of currency are available.

MEMBERSHIP/TABLE FEES 2026:

Nigel Cleminson moved that the current table fees, (\$7 for members, \$9 for visitors) and membership fees (\$74 for home members, \$21 for away members) remain for 2026. Seconded John Bullion. Carried.
