PRESIDENT'S REPORT

It's nearly time again for the Annual General Meeting, when the present management committee come to the end of their elected time in office and a replacement committee is elected. It's also the time the committee reports on events and activities that have taken place during the last 12 months. This year the AGM will be held on Saturday 16th starting at 10:30am. It will be followed by a light lunch and a free bridge afternoon for those who wish to stay and play. I encourage all members to come to the AGM. This is your club, and you should have a say in how it is to be run.

We are in the process of setting up the Presidents Pairs event, which will be run on two Wednesdays – 6th and 13th March. At the time of writing, we have 20 pairs nominated. More will always be better - if we have an even number to balance the draw. The natural method for this event will be Swiss Pairs, where the opponents for each round depend on how well a pair has done in the previous one. The only other constraint is that you can't play against the same pair more than once.

ANZAC Day isn't too far away. The WW1 campaign at Gallipoli forged a link from the bravery and tenacity of soldiers from both countries. This year we are planning a Memorial ANZAC Competition. A trophy is being created by Turgut Manli, who is the Honorary Turkish Consul and a club member. We plan to arrange a single winner event on the 26th of April 2024, and in future years for it to be held either the day before or the day after ANZAC Day. Further information will be provided as we get closer to the date.

TIPS FOR DECLARER

General Advice

1. Don't play to the first trick too quickly. Force yourself to stop and think when dummy comes down.

Look ahead and plan your play to at least the next few tricks.

- 2. Concentrate on the opening lead for a few seconds so you'll remember it later. Decide what it tells you about the leader's length or strength in that suit.
- 3. Mentally review the bidding. If one of your opponents has bid, try to come up with a general picture of his point-count and his length in the suit bid.

Suit Contracts

- 1. Count your losers. Decide which ones can be disposed of or turned into winners (by trumping, by finessing or by discarding them on a side suit).
- Double check by counting your winners. Look at each suit and estimate how many tricks it offers -top tricks and tricks that will be good after you establish the suit.
- 3. If your plan calls for trumping one or more of your losers in the short-trump hand (usually dummy), do that before you lead trumps -- even if you have to give up tricks to set up the trumping position.
- Next, lead trumps, counting as the opponents follow to each trick. Pulling trumps will usually be your best plan if you have good honour strength and/or length in one or more of the outside suits.
- 5. After you've collected all the opponents' trumps, lead your longest side suit. Give up your losers early.

No Trump Contracts

- Count your winners and potential winners. If you don't have enough top tricks to make your contract, decide which suit offers you the best chance of creating more winners.
- 2. Lead that suit first (it will usually be your longest side suit). Give up the tricks you must lose early.
- Stick with one suit at a time. Keep leading it until you've established your tricks (count the defenders' cards as you go), then cash your winners in the suit. When you move to a different suit, start counting again.
- 4. Last, cash honours in your short suits.

BRIDGE TOPIC OF THE MONTH CONDUCT AND ETIQUETTE

COUNT YOUR CARDS

Players should count their cards before looking at them.

If missing or extra cards are discovered once play commences, affected players can be disadvantaged. For example, a missing card is deemed to be part of the hand at all times and a revoke may have occurred.

REMOVING AND REPLACING CARDS

- Cards should not be removed from the board until at least one player from each side is present.
- This also applies to the sit-out pair they must not remove the cards from boards on the sit-out table.
- Cards must be shuffled before being returned to the board.

RECORDING RESULTS

- When you're on opening lead, your first priority after the auction is to make the opening lead.
- This should be done before entering the contract into the Bridgemate or writing on your personal scorer.
- The same applies to dummy after the opening lead is faced, spread your hand before doing anything else.


I bought a fake Koi fish. It's my Dekoi.
